

## AB 1305 Disclosure Statement Purchase of Voluntary Carbon Offsets

Aviation Consultants Inc. (“ACI Jet”) is a privately owned aviation services entity based in California that serves the aviation ecosystem through aircraft ground support and fueling services, maintenance, and full-service aircraft management. In 2025 ACI Jet committed to offsetting all greenhouse gas (“GHG”) emissions associated with its direct emissions and the energy it purchases and uses for its business activities.

The California Voluntary Carbon Market Disclosures Act (Assembly Bill 1305 (“AB 1305”)) requires any entity that purchases and uses voluntary carbon offsets associated with claims concerning significant GHG reductions to make certain disclosures on its website. ACI Jet is providing the following information regarding its carbon offset purchases in compliance with its obligations under AB 1305.

As set forth in detail below, in 2025 ACI Jet purchased 3,400 verified emission reductions (“VERs”) that each represent the environmental benefits associated with the reduction of one metric ton of GHG emissions. The VERs represent emission reductions achieved by two distinct projects: (1) a nitrous oxide (“N2O”) abatement project, known as “Phlogiston Phase I,” located in Cantonment, Florida; and (2) a 108-turbine wind farm project, known as the “Crow Lake Wind Emissions Reduction Project,” located in Chamberlain, South Dakota. The Phlogiston Phase I VERs originated from N2O destroyed in 2021 and subsequently verified in accordance with the Adipic Acid Production Protocol and certified through the Climate Action Reserve. The Crow Lake Wind Emissions Reduction Project VERs originated from electricity generated from a renewable source in 2021 and subsequently verified in accordance with the United Nations Framework Convention on Climate Change (“UNFCCC”) methodology and certified through the Verified Carbon Standard.
